

1. **ELIGIBILITY:** You must be a legal resident of the 50 United States, District of Columbia (or U.S. Guam or U.S. Virgin Islands), Canada, or United Kingdom and 18 years of age and older. You must register for the Spring Break promotion on the Mist website at <https://ai.mist.com/spring-break-kit>. You must (1) confirm a meeting date with a Mist sales representative for video conference or in-person meeting; and (2) provide your business email, and a business address in the United States, Canada or United Kingdom (no P.O. box) where you can receive the Mist spring break promotional kit; (3) and you must attend the video conference or meeting hosted by Mist by end of business April 24, 2019.
